## TERMS AND CONDITIONS FOR JAZZFESTIVAL SAALFELDEN'S SUMMER RAFFLE 2023

# (on Instagram and Facebook)

#### 1. PROMOTION ORGANIZER

The tourism board of Saalfelden located at Mittergasse 21a, 5760 Saalfelden, Austria, has organized this summer raffle (hereinafter, "giveaway") of international scope, which will take place on the internet via Instagram and Facebook, exclusively for participants with residence and stay in Europe in accordance with the provisions in the participation requirements section.

The purpose of this giveaway is to reward the loyalty of the followers of Jazz festival Saalfelden.

#### 2. START DATE AND END DATE

The contest will start on July 13, 2023, 10 a.m. and ends on August 6, 2023, 12 a.m.

## 3. REQUIREMENTS FOR PARTICIPATION AND MECHANICS OF THE GIVEAWAY

The requirements for participation will be as follows:

- Only those who reside and stay in Europe and are aged 18 and over may participate.
- Only users with an Instagram or Facebook account may participate.
- Participants must comment on Jazzfestival Saalfelden's Instagram or Facebook post during the participation period.
- Participants may only take part in the giveaway from a single Instagram/Facebook profile. If a participant is found to be taking part from several accounts, they will be disqualified.
- Even if participants make more than one comment on the post, they will only be given a single participation in the random giveaway.
- The application will accumulate mentions and hashtags from a single participant even if they are in different comments.
- For the participation in the giveaway, it is mandatory that all personal details are true and that the participation takes place only in one's own name.

The prize will consist of 2 x VIP-tickets (value: 165,00 EUR per Ticket) for the Mainstage concerts on Sunday, August 20, 2023 during the Jazzfestival Saalfelden. The prize may not be exchanged for cash or any other prize, nor may it be changed or altered in any way.
